



**BEING A BY-LAW TO ESTABLISH FEES OR CHARGES FOR SERVICES OR ACTIVITIES PROVIDED BY THE TOWN OF COBOURG AND TO REPEAL BY-LAWS 063-2016, 088-2017, 081-2019, 087-2021, 082-2022, 003-2024, 004-2024, 030-2024**

**WHEREAS** section 391 of the *Municipal Act, 2001*, S.O. 2001, c. 25, as amended, provides that a Municipality may pass by-laws imposing fees or charges for services; and

**WHEREAS** section 69 of the *Planning Act*, R.S.O. 1990, c. P.13, as amended, provides that a Municipality may establish a tariff of fees for the processing of applications; and

**WHEREAS** section 7 of the *Building Code Act, 1992*, S.O. 1992, c. 23, as amended, authorizes a Municipal Council to pass by-laws concerning the issuance of permits and related matters; and

**WHEREAS** it is deemed necessary to establish a general fees by-law for The Corporation of the Town of Cobourg.

**NOW THEREFORE BE IT RESOLVED THAT THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE TOWN OF COBOURG ENACTS AS FOLLOWS:**

1. That this By-law may be referred to as the “Fees and Charges By-law”; and
2. That the fee structure and general fees for the various department and organizations of the Town of Cobourg shall be attached hereto and shall form part of this By-law

3. That except as specifically exempted elsewhere in this By-law, all fees and charges are due at the time of application, or where no permit is applicable, at the time when the services has commenced; and
4. That as per section 398 of the *Municipal Act, 2001* fees and charges imposed by this By-law constitute a debt on a property owner and shall entitle the Town to add the amounts to the respective tax roll for any uncollected outstanding balances which are past due; and

5. That should any section of this By-law be declared invalid by court of competent jurisdiction such section shall be construed as being severed here from and the remainder of the By-law shall continue in full force and effect; and
6. That By-laws 063-2016, 088-2017, 081-2019, 087-2021, 082-2022, 003-2024, 004-2024, 030-2024 are hereby repealed once this By-law comes into effect.
7. That this By-law shall come into effect on the 23<sup>rd</sup> day of October, 2024.

**measuring machine** means any machine that measures length, area, volume or capacity, temperature or time; (appareil de mesure)

**reference standard** means a standard that

- (a) represents or registers a unit of measurement referred to in Schedule I or II or that represents or registers a multiple or fraction of such a unit of measurement,
- (b) has been calibrated and certified by the National Research Council of Canada, and
- (c) is or is to be used as a standard for the purpose of determining the accuracy of a local standard; (étalon de référence)

**static measure** means any measure that measures length, volume or capacity and does not have a moving or movable part that has or can have an effect on the accuracy of the measure; (mesure matérialisée)

**trade** means the selling, purchasing, exchanging, consigning, leasing or providing of any commodity, right, facility or service on the basis of measure and includes the business of providing facilities for measuring; (commerce)

**trader** means any person who trades in the course of business; (commerçant)

Basis for units of measurement

Multiples and submultiples of units

Canadian units

(5) The Canadian units of measurement are as set out and defined in Schedule II, and the symbols and abbreviations therefor are as added pursuant to subparagraph 6(1)(b)(ii).

Enforcement

The Weights and Measures Act outlines detailed information regarding the over-measure and short-measure on sale or purchase and/or service.

Short measure on sale

33 (1) Every person who sells or offers for sale any commodity, by number or unit of measurement, is guilty of an offence if the quantity of the commodity that that person delivers or offers for sale is, subject to prescribed limits of error, less than the quantity that that person

- (a) purports to sell or offer for sale; or
- (b) should deliver or offer for sale on the basis of
  - (i) the total price paid or to be paid for the commodity, and
  - (ii) the stated price per number or unit of measurement.

Over measure on purchase

(2) Every person who determines or exercises control over the determination of the quantity of a commodity that that person purchases or offers to purchase by number or unit of measurement is guilty of an offence if the quantity of the commodity that that person receives or offers to purchase is, subject to prescribed limits of error, greater than the quantity that that person

- (a) purports to purchase or offer to purchase; or
